Request for a Design Review (D23-0008) and Conditional Use Permit (CUP24-0002) for a public utility use within an existing two-story commercial building at 1001 Fremont Avenue and the construction of a new 1,554 square-foot one-story storage building at 1579 Miramonte Avenue, located at the northeast corner of Fremont Avenue and Miramonte Avenue.
